After a jury had been secured, Mrs. Thayer was put on the stand by County Attorney McClintock to tell the story of the attempted assault. II. B. She said that she was aroused about 2 o'clock in the morning of Aug. 24 by Antiel climbing in a window. He succeeded in getting inside, but the screams of herself and two children aroused the neighbors, and the man was frightened away. On cross-examination she admitted that after she had caused Antiel's arrest she would have dropped the prosecution of the suit if she could, on account of the defendant's mother, for whom she felt sorry, but was unable to do so.
