Th fact that the officials both in Washington and Superior refuse to disclose their character adds mystery to the affair. Those who know Miss Karon and are her friends declare that there is nothing any more substantial to the charges than alleged "incompe-

tency." She has been in the customs house office here less than a year and previous to that time was employed at a Superior mercantile establishment as a stenographer. O. A. Berg, who is deputy collector of United tSates customs for the Port of Superior, was seen last night by a News Tribune reporter. Berg has charge of the office during the absence of T. B. Mills. He at first refused to

state the nature of the charges night. He said: "In the absence of Mr. Mills I feel it my duty to say nothing concerning the charges. Of course, I know of them, and in fact have for some little time.
