RABBI IS OPPOSED TO INTERMARRIAGE

Rev. Dr. Mendel Silber Tells His Duluth Congregation

That He Sees In It Race Suicide and a Desertion From the Battle Jews Have Been Placed Here to Fight.

"No matter how much theologians, scientists and philosophers may differ as to the origin and destiny of man, one thing they are all agreed on, and that is the duty of self-preservation and what is true of the individual is

and what is true of the many data also true of the race. "Self-murder is universally regarded as a dastardly crime because it is desertion from the momentous battle we serion from the momentous pattle we are placed here to fight, but many fall to see the logic of this truth when apto see the logic of this truth when applied to the race. And it is here exactly that many of those who recently entered into the intermarriage controversy have failed to see the point. They argued the question only from a utili-

arguet the question only from a con-tarian or religious standpoint. "Though it be true that in most cases mixed marriages turn out uncases mixed marriages turn out unhappily, many instances may be shown in which they proved the reverse. Are we, then, to approve of some and disapprove of others? Where is the line to be drawn, and how are we to foretell which will be happy and which

unhappy?
"Though it may also be true that marriages between Jew and non-Jew, as between Catholic and Prostestant, as between Cathons and are a detriment to their respective re-ligions and are on this ground to be rejected by the church, yet in the long run things would be equalized, for there would be as many converts as

apostates. "But there is a stronger and more potent reason for rejecting intermarriage. The Jewish people is not only a religious community but also a racial unit. And it is from this standpoint mainly that we may not tolerate mixed marriages. From a religious standmarriages. From a rengious stand-point it would be more tolerable. Let us take as an instance a Jewish girl marrying a non-Jew. The ceremony takes place in a church and the young lady by accepting what is called the sacrament of marriage becomes Christian.

"The synagogue would require cor-siderable more sacrifice on the part of the man, but it would accomplish a similar result if it would make of him

"Mixed marriage is undoubtedly a form of individual assimilation and as such objectionable. We are in the long run as dependent on our numerical strength as any other nation. We have strength as any other nation. We have survived because our birth rate has always been so well ahead of our death rate, and we all exist through death rate, and we all each other, our inter-dependence on each other. We Jews are honestly justified in looking askance on mixed marriage.

"We do not say that the mon-Jews are not good enough for us. Some are individually our superior; some are individually our interior, but the question of social or any other form of equality has nothing to do with the issue. The genius of race seeks life and maintenance. We ourselves wish to live and be preserved. We love our ideas and our understanding of them for that matter, and not some one else's intermatter. our understanding of them for that matter, and not some one else's interpretation. For that we need our own bodies, our own blood, our own cast of cranium, and since ideas are eternal we, wish our successors to be of our own stock so that they may be actuated by the same sentiments."

"Lest I be branded as narrow-minded and clannish because of my opposition to intermarriage, I wish to say that I am also opposed to marriage of blood-relations.
