Charged With Destroying Property.

A laborer giving his name as John Hawkins, 41 years old, was arrested last night at the new Soo line station, Sixth avenue west and Superior street, on a charge of destruction of personal property. Hawkins is alleged to have broken an article of furnishing in the men's comfort room of the station.

Peter Marosis Is Dead.

Peter Marosis, a prominent Greek of Minneapolis, died Thursday evening at Mason City, Iowa, where he had gone to look after the interests of certain Greek workingmen. He was one of the earliest of Greek pioneers. He was the founder of the first Greek church of Minneapolis, and invariably took the lead in all the charitable and philanthropic activities of his people.

Arrested For Superior Police.

Ole Nelson, a laborer, aged 26 years, was arrested at the Union passenger station last night by Policeman Hinricks for the Superior police. Nelson is alleged to have taken a quantity of wearing apparel from a Superior rooming house, that did not belong to him.

Collector Arrested.

John Thomas was arrested yesterday morning upon complaint of the Tessman-Hintz company, wholesale feed dealers, at 114-16 East Michigan street. It was alleged that Thomas failed to turn in \$6.75 of the company's money, which he had collected for goods delivered.

Must Support Family.

John Ryan was given two months by the municipal court yesterday morning to show that he will keep his promise to support his family. He was arrested upon complaint of his wife, who charged him with buying more liquor than he did groceries.

Peddled Without License.

Pleads Not Guilty.

Frank Wilkosz pleaded not guilty yesterday morning to a charge of assault and battery preferred by Mrs. Margaret Dillon. Mrs. Dillon alleges that the defendant struck her in the face while she was leading a cow along the street.

Case Is Dismissed.

Judge Cutting yesterday dismissed the case of the city of Duluth against William Devaney, charged with not properly protecting a blast about three weeks ago at Nineteenth avenue east and Fifth street, at which time Mrs. George Smith was struck by a rock hurled by the explosion through a window near which she was sitting in a relative's house. Insufficient evidence was produced to show that Devaney was neglectful.

Dies At Hospital.

Capt. John Wilcox, 54 years old, died last evening at St. Mary's hospital after a short illness. Kidney trouble is said to be the cause of his death. He resided at 14 Fourth avenue east. He leaves a wife and several children.

Fined For Fighting.

As the result of a declaration that he could whip Charles G. Carlson, barn-man for the East End Ice company, Wilson Knight, and his wife, Mary, were ordered by Judge Cutting of the municipal court to pay fines and costs aggregating \$59.44. The Knights were given until May 27 to raise the amount. Failure to do so will mean 20 days in jail for Mrs. Knight and 10 days for her husband.
