Whatever the Outcome, France, **England and Germany Will** Be Affected.

By a German Army Officer. Weeks have passed since the begin ning of the great European war, but the comparatively small army of neutral Belgium has borne the brunt of the attack. The little kingdom, which war. was drawn into the conflict on account of the strategical value of its location, has thus suddenly jumped into prominence, and once more will go down in history as an important factor in the development of Europe's future. The people who up to this time have so valiantly defended their country are the descendants of a race of warriors.

The eighteenth century brought another war with France, and only the French Revolution of 1830 offered the long desired opportunity to create an independent Belgium, which, extended over an area of only a little over 11,000 square miles, can boast of a wonderful national prosperity, due to abundant agriculture and boundless wealth in coal and iron.

To England as Last Move. Will the Belgian government be removed to England, where often before homeless royalty has sought and found hospitality, or will the Belgian ruler, surrounded by his army, fall

back into France? Since it was France which mainly benefited by the Belgian resistance t was a logical conclusion that a French army would speedily support and relieve the Belgians, and the arrival of the French troops in Belgium was promptly reported. The English who went to war to protect Belgium's integrity, lost no time in sending her troops across the channel to join the French soldiers in building a wall against the invaders.


