### ST. PAUL TO HAVE COMMUNITY CHEST.

**Jewish Men on First Board.**  
After many months of deliberation over the advisability of organizing the so-called "Community Chest" for charitable and social agencies in St. Paul, the idea was formally adopted by a vote of the different agencies, of all denominations, of the city. The Community Chest will be the organization through which the funds for the various charities and relief funds will be raised by popular subscription, avoiding duplication of effort and waste of money in the conduct of campaigns, all money to be raised in one fund, and then distributed proportionately. The organization is to be managed by a Board of thirteen directors, twelve of whom have already been selected, consisting of two Jewish men. These two are S. W. Dittenhoefer and Isaac Summerfield.

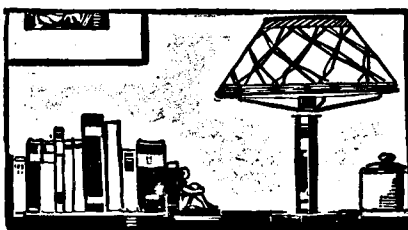
