Disapproval of a proposed law for the establishment by hig companies and corporations of a hospital with medical service for employes was volced by the St. Louis County Medical society at its annual meeting last night at the Commercial club. Dr. E.

In outlining reasons for opposition to the proposed measure, which will be introduced at the next session of the legislature, it was pointed out that such a plan discourages the best efforts of men engaged in the medical profession *to exert themselves in greater personal advancement and higher study. Dr. O. W. Rowe, who presided at the meeting, addressed the society on medical problems. He also outlined the disadvantages of the proposed legislation to, establish medical and hospital aid for employes. He said, "Medical men all over the country strongly denounce this plan which is being promoted by organizations of men who are neither workingmen nor medical men." Denounces

A talk was given by County Attorney Warren E. Greene who expression for its co-operation and aid to the state. He also voiced his disapprova, of the tendency to standardize individuals, regardless of personal ability, which he pictured as the result of legislation which made possible the estant'shment of hospitals and medical aid to employes of corporations.
