

\$60,000 TOTAL DAMAGES ASKED IN CIVIL SUITS

Fifteen Actions Filed for Hearing During November Term of District Court

Fifteen complaints, in which the defendants seek redress totaling more than \$60,000, were filed in district court yesterday, the last day for filing notes of issue for the November term of district court. The term opens Wednesday when the grand jury meets. The petit jury will convene Nov. 8.

Three actions, each for \$115, were instituted by the Farmers' Terminal Packing company against Anna Korpi and John Simme. The suits are brought to force payment of notes.

Blwabik Physician Defendant.

Mildred M. Barrett seeks to recover \$2,400 from Raymond E. Copeland for alleged wrongful detention of an automobile. Dr. C. W. Bray, of Blwabik, is made defendant in a suit for \$4,500, instituted by Emil Jalonen, who alleges malpractice.

Alleging a Foster Motor company automobile driven by Raymond Dinham, was operated carelessly on the Miller Trunk highway, Gust Krantz filed suit against the company and Dinham for \$1,000. John Pihlaja asks \$5,000 from William Hoffren on a charge of assault.

Claims Misrepresentation.

Alleging that Joseph E. Davis, misrepresented the credit of a third party, A. Oreckovsky seeks to recover \$200.30. Oreckovsky claims he sent the money to a furniture dealer in Chicago to pay for a set of furniture but never received the goods.

Harry Silk filed suit for \$5,000 damages against Julius Garon. The suit is based on alleged injuries his wife received when she fell down the steps of their home. Mrs. Silk seeks \$10,000 damages. Garon is the owner of the house.

As the result of alleged injuries received when struck by an automobile driven by Frank Talafous, Edna Wright seeks \$5,050 damages.

City Made Defendant.

The city of Duluth is made defendant in an action for \$4,000 instituted by Margaret H. McLean. She tripped while crossing First avenue West and Superior street because of the elevated street car tracks, she claims.

Suit for \$2,084.80 was filed by the Standard Oil company against the Mountain Iron General Construction company and the Maryland Casualty company, for money due on goods sold the defendant, the complaint states. The casualty company is made defendant as it bonded the construction concern when it entered into a contract with St. Louis county.

Injuries Basis of \$20,750 Suit.

Nels M. Homer filed suit for \$20,750 against T. W. Moran and Charles Mork. He was employed by Moran as stevedore in the hold of the steamer Superior. While he was working in the hold, the complaint states, a sack of bran being thrown below under the direction of Mork, struck Homer, the complaint alleges.

Luigie Senarghi asks that the books of a grocery store in which he was a partner with Mike Bruno be examined. He states Bruno has refused to allow him to audit the books so that the profits can be divided.
